AN ACT

To appropriate the sum of \$225,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2014, for the purpose of humanitarian relief efforts for victims of Typhoon Haiyan in the Republic of the Philippines, the Republic of Palau, the State of Yap and the Socialist Republic of Vietnam, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. The sum of \$225,000 is hereby appropriated from 2 the General Fund of the Federated States of Micronesia for the 3 fiscal year ending September 30, 2014. The funds appropriated 4 under this section shall be used to fund humanitarian relief 5 efforts for victims of Typhoon Haiyan in the Republic of the 6 Philippines, the Republic of Palau, the State of Yap and the 7 Socialist Republic of Vietnam.

5	such funds shall lapse on September 30, 2014.	
6	Section 3. This act shall become law upon approval by the	
7	President of the Federated States of Micronesia or upon its	
8	becoming law with such approval.
