AN ACT

To amend Public Law No. 18-42, by amending section 1 thereof, to change the use of certain funds previously appropriated therein, to fund the airport terminal facilities improvement and the upgrade of equipment of the Aircraft Rescue and Fire Fighting (ARFF) buildings in the States of Kosrae, Chuuk, Yap and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 1 of Public Law No. 18-42 is hereby
2	amended to read as follows:
3	"Section 1. The sum of \$400,000 is hereby
4	appropriated from the General Fund of the Federated
5	States of Micronesia for the fiscal year ending
6	September 30, 2014. The funds appropriated under
7	this section shall be used to fund the improvement of
8	airport terminal facilities and the upgrade of
9	equipment of the Aircraft Rescue and Fire Fighting
10	(ARFF) buildings in the States of Kosrae, Chuuk,
11	Pohnpei and Yap:
12	(1) Airport Terminal Facility Improvement in
13	Chuuk\$ 125,000
14	(2) Airport Terminal Facility Improvement
15	in Kosrae and upgrade or replacement of
16	ARFF switchgear or Transformer 100,000
17	(3) Airport Terminal Facility (passenger
18	processing areas) Improvement in Yap 100,000

1	(4) Airport Terminal Facility Improvement									
2	in Pohnpei\$ 75,000									
3	Section 2. Allotment and management of funds and lapse									
4	date. All funds appropriated by this act shall be allotted,									
5	managed, administered and accounted for in accordance with									
6	applicable laws, including, but not limited to, the Financial									
7	Management Act of 1979. The allottee shall be responsible for									
8	ensuring that these funds, or so much thereof as may be									
9	necessary, are used solely for the purpose specified in this									
10	act, and that no obligations are incurred in excess of the sum									
11	appropriated. The allottee of the funds appropriated under									
12	this act shall be the respective Governor of each of the									
13	States, except the allottee for Pohnpei State's share of									
14	Airport funds shall be the Pohnpei Port Authority and the									
15	allottee of Kosrae State's share of fund shall be the Kosrae									
16	Port Authority. The authority of the allottee to obligate									
17	funds appropriated by this act shall lapse on September 30,									
18	2015.
