PUBLIC LAW NO. 18-79

AN ACT

To further amend Public Law No. 16-62, as amended by Public Laws Nos. 16-71, 17-05, 17-18, 17-29, 17-47, 18-23, 18-33 and 18-50, by amending section 6 thereof, to change the lapse date of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 16-62, as amended by
- 2 Public Laws Nos. 16-71, 17-05, 17-18 and 18-23, is hereby further
- 3 amended to read as follows:

4	"Section 6. Allotment and management of funds and
5	lapse date. All funds appropriated by this act shall
6	be allotted, managed, administered and accounted for
7	in accordance with applicable law, including, but not
8	limited to, the Financial Management Act of 1979.
9	The allottee shall be responsible for ensuring that
10	these funds, or so much thereof as may be necessary,
11	are used solely for the purpose specified in this
12	act, and that no obligations are incurred in excess
13	of the sum appropriated. The allottee of funds
14	appropriated under sections 2 and 4 of this act shall
15	be the President of the Federated States of
16	Micronesia or his designee, PROVIDED THAT the
17	allottee of funds appropriated under subsection
18	4(1)(c) of this act shall be the Pohnpei
19	Transportation Authority, the allottee of funds

1	appropriated under subsection 4(2)(c) of this act
2	shall be the Secretary of the Department of Resources
3	and Development or his designee, the allottee of
4	funds appropriated under subsections 4(3)(b), 4(3)(c)
5	and 4(3)(j) of this act shall be the Luhkenmoanlap of
6	Kitti Municipal Government and the allottee of funds
7	appropriated under subsection 4(3)(i) of this act
8	shall be the Meninkeder Lapalap of Madolenihmw
9	Municipal Government. The allottee of funds
10	appropriated under section 3 of this act shall be the
11	Governor of Yap State. The allottee of funds
12	appropriated under subsections 5(1) and 5(3) shall be
13	the Governor of Chuuk or his designee. The allottee
14	of funds appropriated under subsection 5(2) of this
15	section 5 of this act shall be the Mortlocks Islands
16	Development Authority. The allottee of funds
17	appropriated under subsection 5(4) of section 5 of
18	this act shall be the Executive Director of the
19	Southern Namoneas Development Authority. The
20	allottee of funds appropriated under subsection 5(5)
21	of section 5 of this act shall be the Faichuk
22	Development Authority. The allottee of funds
23	appropriated under subsection 5(6) of section 5 of
24	this act shall be the Northwest Development
25	Authority. The funds appropriated by this act shall

1	lapse on September 30, 2015."	
2	Section 2. This act shall become law upon approval by th	.e
3	President of the Federated States of Micronesia or upon its	
4	becoming law without such approval.
