PUBLIC LAW NO. 18-82

AN ACT

To further amend Public Law No. 18-05, as amended by Public Laws Nos. 18-07, 18-14, 18-31, 18-38 and 18-72, by amending sections 2, 4 and 6 thereof, for the purpose of changing the use and lapse date of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

15	Section 3. Section 6 of Public Law No. 18-05, as amended by
16	Public Laws Nos. 18-07 and 18-38, is hereby further amended to
17	read as follows:
18	"Section 6. Allotment and management of funds and
19	lapse date. All funds appropriated by this act shall
20	be allotted, managed, administered and accounted for
21	in accordance with applicable laws, including, but
22	not limited to, the Financial Management Act of 1979.
23	The allottee shall be responsible for ensuring that
24	these funds, or so much thereof as may be necessary,
25	are used solely for the purpose specified in this

1	act, and that no obligations are incurred in excess
2	of the sum appropriated. The allottee of the funds
3	appropriated under section 3 of this act shall be the
4	Governor of Yap State. The allottee of funds
5	appropriated under sections 2 and 4 of this act shall
6	be the President of the Federated States of
7	Micronesia or his designee, EXCEPT THAT the allottee
8	of funds appropriated under subsection 4(3)(a) of
9	this act shall be the Pohnpei Transportation
10	Authority. The allottee of funds appropriated under
11	subsections $5(1)$ and $5(3)$ of this act shall be the
12	Governor of Chuuk State or his designee. The
13	allottee of funds appropriated under subsection 5(2)
14	of section 5 of this act shall be the Mortlock
15	Islands Development Authority. The allottee of funds
16	appropriated under subsection 5(4) of section 5 of
17	this act shall be the Southern Namoneas Development
18	Authority. The allottee of funds appropriated under
19	subsection 5(5) of section 5 of this act shall be the
20	Faichuk Development Authority. The allottee of funds
21	appropriated under subsection 5(6) of section 5 of
22	this act shall be the Northwest Island Development
23	Authority. The authority of the allottee to obligate
24	funds appropriated by this act shall lapse on
25	September 30, 2015."

1	Section 4. This act shall be	come law upon approval by the
2	President of the Federated States	of Micronesia or upon its
3	becoming law without such approval
