AN ACT

To further amend Public Law No. 16-49, as amended by Public Laws Nos. 16-68, 16-76, 17-06, 17-10, 17-23, 17-30, 17-32, 17-45, 17-82, 17-85, 18-28, 18-45 and 18-59, by amending section 6 thereof, for the purpose of changing the lapse date of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 6 of Public Law No. 16-49, as amended
by Public Laws Nos. 17-10, 17-45, 17-85 and 18-28, is further
hereby amended to read as follows:

"Section 6. Allotment and management of funds and lapse 4 date. All funds appropriated by this act shall be 5 allotted, managed, administered and accounted for in 6 7 accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. 8 The 9 allottee shall be responsible for ensuring that these 10 funds, or so much thereof as may be necessary, are used 11 solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum 12 13 appropriated. The allottee of funds appropriated under 14 sections 2 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; 15 16 PROVIDED THAT the allottee of funds appropriated under section 4(1)(b) shall be the Pohnpei Transportation 17 18 Authority and the allottee of the funds appropriated

1	under section 4(1)(j) shall be the Mayor of Kolonia Town
2	Government. The allottee of funds appropriated under
3	section 3 of this act shall be the Governor of Yap State.
4	The allottee of funds appropriated under subsections
5	5(1), $5(3)$ and $5(7)$ of this act shall be the Governor of
6	Chuuk State or his designee. The allottee of funds
7	appropriated under subsection 5(2) of this act shall be
8	the Mortlock Islands Development Authority (MIDA). The
9	allottee of funds appropriated under subsection 5(4) of
10	this act shall be the Southern Namoneas Development
11	Authority. The allottee of funds appropriated under
12	subsection 5(5) of this act shall be the Faichuk
13	Development Authority. The allottee of funds
14	appropriated under subsection 5(6) of this act shall be
15	the Northwest Development Authority. The funds
16	appropriated by this act shall lapse on September 30,
17	2015."
