A RESOLUTION

To ratify the Treaty between the Federated States of Micronesia and the Republic of Palau Concerning the Maritime Boundaries and Cooperation on Related Matters, which was signed on behalf of both State Parties in 2006.

1 WHEREAS, the jurisdiction over certain territory and waters of the Federated States of Micronesia is set forth in Article I of 2 the Constitution of the Federated States of Micronesia and 3 elaborated upon in title 18 of the Code of the Federated Stats of 4 Micronesia, including assertion of an exclusive economic zone 5 extending up to 200 nautical miles outward from baselines; and 6 7 WHEREAS, the Constitution of the Federated States of Micronesia permits limitation for jurisdiction over waters 8 pursuant to international treaty obligations; and 9 10 WHEREAS, the Exclusive Economic Zones of the Federated States 11 of Micronesia and the Republic of Palau overlap in some areas; and WHEREAS, the international practice in this circumstance is 12 to negotiate a treaty establishing the boundaries of each nation's 13 14 waters; and WHEREAS, the Treaty between the Federated States of 15

16 Micronesia and the Republic of Palau Concerning Maritime 17 Boundaries and Cooperation on Related Matters establishes a line 18 of delimitation between the Exclusive Economic Zones over which 19 each nation respectively exercises sovereign rights and/or 20 jurisdiction; and

7	BE IT RESOLVED by the Eighteenth Congress of the Federated
8	States of Micronesia, Third Regular Session, 2014, that Congress
9	hereby ratifies the Treaty Between the Federated States of
10	Micronesia and the Republic of Palau Concerning Maritime
11	Boundaries and Cooperation on Related Matters, which was signed on
12	behalf of both State Parties in 2006; and
13	BE IT FURTHER RESOLVED that a certified copy of this
14	resolution be transmitted to the President of the Federated States
15	of Micronesia.
