A BILL FOR AN ACT

To amend sections 1 and 3 of Public Law No. 19-32, by appropriating a supplemental budget in the amount of \$350,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2016, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 19-32, is hereby

2 amended to read as follows:

3 "Section 1. Title. The title of this act is as follows: 4 To appropriate the sum of \$[75,429,823] 75,779,823 from 5 the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2016, for the 6 purpose of funding the operations of all branches of the 7 National Government of the Federated States of 8 Micronesia, its agencies, various programs, grants, 9 10 subsidies and contributions and Capital and Human Resources Development. The National Government's share 11 12 of the Amended Compact funds has been reduced to zero 13 except that the National Government will retain 10 percent of the Supplemental Education Grant funds as is 14 15 reflected in the budget for the Department of Education. 16 The sum appropriated herein shall be apportioned as 17 follows:"

18 Section 2. Section 3 of Public Law No. 19-32 is hereby 19 amended to read as follows:
