Dear Speaker Simina:

I am transmitting the following Congressional Act, which I have signed to become Public Law No. 19-26:

congressional act no. 19-26, entitled: "an act to amend public law no. 19-10, by amending sections 3, 4, 5 and 6 thereof, to change the use and allottee of funds previously appropriated therein for the purpose of funding public projects and social programs in the states of Pohnpei, Kosrae and Chuuk, to offer technical amendments, and for other purposes."

The act amends Public Law No. 19-10, which I signed into law on July 24, 2015. The amendments involve changing the use or the amounts of public projects and social programs for Kosrae, Pohnpei At-Large, Pohnpei ED#2, and Chuuk ED#2.

The act rectifies the errors in section 6 of Public Law No. 19-10 and changes certain allottees of funds for Kosrae and for Pohnpei.

AN ACT

To amend Public Law No. 19-10, by amending sections 3, 4, 5 and 6 thereof, to change the use and allottee of funds previously appropriated therein for the purpose of funding public projects and social programs in the States of Pohnpei, Kosrae and Chuuk, to offer technical amendments, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

18 Section 4. Section 6 of Public Law No. 19-10 is hereby
19 amended to read as follows:

20 "Section 6. Allotment and management of funds and
21 lapse date. All funds appropriated by this act shall
22 be allotted, managed, administered and accounted for
23 in accordance with applicable laws, including, but not
24 limited to, the Financial Management Act of 1979. The
25 allottee shall be responsible for ensuring that these

1 funds, or so much thereof as may be necessary, are
2 used solely for the purpose specified in this act, and
3 that no obligations are incurred in excess of the sum
4 appropriated. The allottee of the funds appropriated
5 under section 2 of this act shall be the Governor of
6 Yap State. The allottee of funds appropriated under
7 sections 3 and 4 of this act shall be the President of
8 the Federated States of Micronesia or his designee;
9 PROVIDED THAT, the allottee of funds appropriated
10 under subsections 3(a), (b), (c), (d), (e), (f), (g),
11 (h), (i), (j) and (k) of this act shall be the Mayor
12 of Lelu Town Government; the allottee of funds
13 appropriated under subsections 4(3)(a) and 4(3)(b) of
14 this act shall be the Pohnpei Transportation
15 Authority, and the allottee of funds appropriated
16 under subsections 4(3)(f) and 4(3)(h) of this act
17 shall be the Pohnpei Utility Corporation. The
18 allottee of funds appropriated under subsections 5(1),
19 5(3) and 5(6) of this act shall be the Governor of
20 Chuuk State or his designee. The allottee of funds
21 appropriated under subsection 5(2) of this act shall
22 be the Mortlock Islands Development Authority. The
23 allottee of funds appropriated under subsection 5(4)
24 of this act shall be the Southern Namoneas Development
25 Authority. The allottee of funds appropriated under

1 subsection 5(5) of this act shall be the Faichuk
2 Development Authority. The authority of the allottee
3 to obligate funds appropriated by this act shall lapse
4 on September 30, 2017."

5 Section 5. This act shall become law upon approval by the
6 President of the Federated States of Micronesia or upon its
7 becoming law without such approval.
