PUBLIC LAW NO. 19- 42

AN ACT

To further amend Public Law No. 19-10, as amended by Public Law No. 19-26, by amending sections 2, 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs in the States of Yap and Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 19-10 is hereby
2 further amended to read as follows:

3 "Section 2. Of the sum of \$2,800,000 appropriated by
4 this act, \$400,000 is apportioned for public projects
5 and social programs in the State of Yap.

5 Section 2. Section 3 of Public Law No. 19-10, as amended by
 6 Public Law No. 19-26, is hereby further amended to read as
 7 follows:

8 "Section 3. Of the sum of \$2,100,000 appropriated by
 9 this act, \$400,000 is apportioned for public projects
 10 and social programs in the State of Kosrae.

11 Section 3. Section 6 of Public Law No. 19-10, as amended
 12 by Public Law No. 19-26, is hereby further amended to read as
 13 follows:

14 "Section 6. Allotment and management of funds and
 15 lapse date. All funds appropriated by this act shall
 16 be allotted, managed, administered and accounted for
 17 in accordance with applicable laws, including, but
 18 not limited to, the Financial Management Act of 1979.
 19 The allottee shall be responsible for ensuring that
 20 these funds, or so much thereof as may be necessary,
 21 are used solely for the purpose specified in this
 22 act, and that no obligations are incurred in excess
 23 of the sum appropriated. The allottee of the funds
 24 appropriated under section 2 of this act shall be the
 25 Governor of Yap State; PROVIDED THAT, the allottee of

1 funds appropriated under subsection 2(h) of this act
2 shall be the President of COM-FSM. The allottee of
3 funds appropriated under sections 3 and 4 of this act
4 shall be the President of the Federated States of
5 Micronesia or his designee; PROVIDED THAT, the
6 allottee of funds appropriated under subsections
7 4(a), (b), (c), (d), (e), (f), (g), (h), 9(i), (j)
8 and (k) shall be the Mayor of Lelu Town Government,
9 the allottee of funds appropriated under subsections
10 3(a), (b), (c), (d), (e), (f), (g), (h), (i), (j) and
11 (k) of this act shall be the Pohnpei Transportation
12 Authority. The allottee of funds appropriated under
13 subsections 5(1), 5(3) and 5(6) of this act shall be
14 the Governor of Chuuk State or his designee. The
15 allottee of funds appropriated under subsection 5(2)
16 of this act shall be the Mortlock Islands Development
17 Authority. The allottee of funds appropriated under
18 subsection 5(4) of this act shall be the Southern
19 Namoneas Development Authority. The allottee of
20 funds appropriated under subsection 5(5) of this act
21 shall be the Faichuk Development Authority. The
22 authority of the allottee to obligate funds
23 appropriated by this act shall lapse on September 30,
24 2017."

PUBLIC LAW No. 19-42

1 Section 4. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
