AN ACT

To further amend section 632 of title 55 of the Code of the Federated States of Micronesia (Annotated), as amended by Public Law No. 19-39, to correct a technical error, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 632 of title 55 of the Code of the  
2       Federated States of Micronesia (Annotated), as amended by  
3       Public Law No. 19-39, is hereby further amended to read  
4       as follows:


5               "Section 632. Deposits. All future appropriations for  
6               the Fund as well as revenues received pursuant to the  
7               provisions of section 403(2) of title 24 of this code  
8               shall be deposited in the Fund. Any unexpended moneys  
9               in this Fund shall not revert to the General Fund nor  
10              lapse at the end of the fiscal year; PROVIDED,  
11              HOWEVER, that any amount in excess of \$1,000,000 shall  
12              be paid into the General Fund."

1       Section 2. This act shall become law upon approval by

3 its becoming law without such approval.
