
Dear Speaker Simina:

I am pleased to transmit the following Congressional Act, which became Public Law No. 19-53, as follows:

Congressional Act No. 19-53, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 18-35, AS AMENDED BY PUBLIC LAWS NOS. 18-49, 18-61, 18-63, 18-78, 18-98, 18-111, 18-123, 19-06, 19-12, 19-40 AND 19-48, BY AMENDING SECTION 4 THEREOF, TO CHANGE THE USE OF FUNDS PREVIOUSLY APPROPRIATED THEREIN, TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS FOR THE PEOPLE OF THE STATE OF POHNPEI, AND FOR OTHER PURPOSES."

This act does not appropriate additional funds but it changes the use of certain funds for public projects and social programs previously appropriated for the State of Pohnpei. There being no constitutional issue involved, I have signed the act to become a public law.

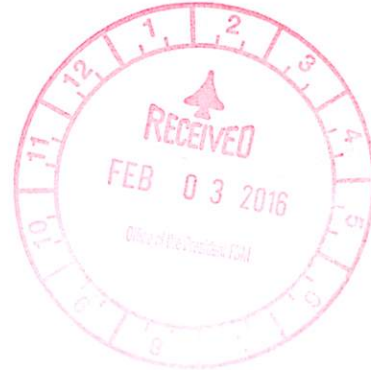

PUBLIC LAW No. 19-53

AN ACT

To further amend Public Law No. 18-35, as amended by Public Laws Nos. 18-49, 18-61, 18-63, 18-78, 18-98, 18-111, 18-123, 19-06, 19-12, 19-40 and 19-48, by amending section 4 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs for the people of the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 18-35, as amended by
2 Public Laws Nos. 18-49, 18-61, 18-63, 18-78, 18-94, 18-111, 19-06,
3 19-12 and 19-48, is hereby further amended to read as follows:

4 "Section 4. Of the sum of \$4,900,000 appropriated by

6 projects and social programs in the state of Pohnpei.
