
Dear Speaker Simina:

PUBLIC LAW No. 19-63

AN ACT

To amend section 204 of title 2 of the Code of the Federated States of Micronesia (Annotated), to provide for an Office of Veteran's Affairs, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 204 of title 2 of the Code of the
2 Federated States of Micronesia (Annotated), is hereby amended to
3 read as follows:

4 "Section 204. Other Executive Offices.

5 There shall be the following executive offices:

6 (1) Office of the Public Defender;

7 (2) Office of Statistic, Budget, Overseas Development
8 Assistance and COMPACT Management;

9 (3) Office of Environment and Emergency Management;

10 (4) Office of National Archives, Culture and Historic
11 Preservation; and

12 (5) Office of Veteran's Affairs."


