
Dear Speaker Simina:

PUBLIC LAW No. 19-131

AN ACT

To appropriate a supplemental budget in the amount of \$556,074 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2017, by amending the title and sections 1 and 9 of Public Law 19-118, as amended by Public Law 19-125, to fund a particular project out of the Supplemental Education Grant (SEG) funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The title of Public Law 19-118, as amended by
2 Public Law No. 19-125, is hereby further amended to read as
3 follows:

4 "AN ACT to appropriate \$70,357,055 from the General
5 Fund of the Federated States of Micronesia for the
6 fiscal year ending September 30, 2017, to provide
7 funding for the operations of all branches of the
8 National Government of the Federated States of
9 Micronesia, its agencies, various programs, grants,
10 subsidies and contributions and Capital and Human
11 Resources Development, and for other purposes."

12 Section 2. Section 1 of Public Law 19-118, as amended by
13 Public Law No. 19-125, is hereby further amended to read as
14 follows:

15 "Section 1. Purpose. The purpose of this act
16 is as follows: To appropriate the sum of
17 \$70,357,055 from the General Fund of the

1 Federated States of Micronesia for the fiscal
2 year ending September 30, 2017, for the purpose
3 of funding the operations of all branches of the
4 National Government of the Federated States of
5 Micronesia, its agencies, various programs,
6 grants, subsidies and contributions and Capital
7 and Human Resources Development. The National
8 Government's share of the Amended Compact funds
9 has been reduced to zero; EXCEPT THAT, the
10 National Government will retain 10 percent of
11 the Supplemental Education Grant funds as is
12 reflected in the budget for the Department of
13 Education. The sum appropriated herein shall be
14 apportioned as follows:"

15 Section 3. Section 9 of Public Law 19-118 is hereby
16 amended to read as follows:

17 "Section 9. Capital and Human Resources Development.
18 The sum of \$31,320,973, or so much thereof as may be
19 necessary, is hereby appropriated from the General
20 Fund of the Federated States of Micronesia for the
21 fiscal year ending September 30, 2017, for the
22 following capital improvements, development programs,
23 and projects and human resources development. Of the
24 total amount of funds appropriated herein, \$1,802,096
25 shall be deemed to come from funds available under the

Amended Compact from the Supplemental Education Grant and \$9,545,500 shall be deemed to come from funds available under the Amended Compact from Compact Sector Grants. The sum appropriated by this section shall be apportioned as follows:


