

PUBLIC LAW No. 19-124

AN ACT

To appropriate the sum of \$12,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2017, for the purpose of funding priority infrastructure projects in all of the four states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$12,000,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2017, for the purpose of funding priority
5 infrastructure projects in all of the four states. The funds
6 appropriated under this section shall be apportioned as follows:

7 Section 2. Of the \$12,000,000 appropriated under this act,
8 \$1,750,000 shall be apportioned for priority infrastructure
9 projects in the state of Yap.

 7 \$6,250,000 shall be apportioned for priority infrastructure
 8 projects in the state of Chuuk.

15 Section 6. Allotment and management of funds and lapse date.
 16 All funds appropriated by this act shall be allotted, managed,
 17 administered and accounted for in accordance with applicable laws,
 18 including, but not limited to, the Financial Management Act of
 19 1979. The allottee shall be responsible for ensuring that these
 20 funds, or so much thereof as may be necessary, are used solely for
 21 the purpose specified in this act, and that no obligations are
 22 incurred in excess of the sum appropriated. The allottee of the
 23 funds appropriated under section 2 of this act shall be the
 24 Governor of the State of Yap or his designee. The allottee of the
 25 funds appropriated under sections 3 and 4 of this act shall be the

1 President of the Federated States of Micronesia or his designee;
2 PROVIDED THAT, the allottee of funds appropriated under
3 subsections 4(1)(c) through 4(1)(o) and 4(2)(f) shall be the
4 Pohnpei Transportation Authority (PTA); the allottee of funds
5 appropriated under subsections 4(1)(b), 4(2)(a), 4(2)(c), 4(2)(d)
6 and 4(2)(e) shall be the Mayor of Kolonia Town Government; the
7 allottee of funds appropriated under subsections 4(1)(a), 4(2)(b),
8 4(2)(g), 4(2)(h), 4(2)(i), 4(2)(j) and 5(1)(c) shall be the
9 Secretary of the Department of Transportation, Communications and
10 Infrastructure or his designee. The allottee of the funds
11 appropriated under section 5 of this act shall be the Governor of
12 Chuuk State or his designee. The authority of the allottee to
13 obligate funds appropriated by this act shall lapse on September
14 30, 2017.


