PUBLIC LAW No. 19- 128

AN ACT

To further amend Public Law No. 18-11, as amended by Public Laws Nos. 18-44, 18-81, 19-33 and 19-106, by amending section 1 and 2 thereof, to change to use and allottee of funds previously appropriated therein for the states of Pohnpei and Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 18-11, as amended
2 by Public Law No. 18-44, is hereby further amended to read as
3 follows:

4 "Section 1. The sum of \$1,680,000, or so much thereof
5 as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 2013, for the
8 purpose of funding public projects and social programs
9 in the states of Pohnpei and Yap. The funds shall be
10 apportioned as follows:

11 1. Pohnpei State \$ 1,130,000

12 PROVIDED, HOWEVER, that the funds appropriated in
13 subsections (b)(c)(d) and (e) of this section shall
14 not be allotted until Congress is officially advised
15 that funds improperly disbursed as a result of the
16 line item veto which was reflected in Public Law No.
17 18-11 are collected.

21	Section 2. Section of Public Law No. 18-11, as amended by	
22	Public Laws Nos. 18-44, 18-81, 19-33 and 19-106, is hereby	
23	further amended to read as follows:	
24	"Section 2. Allotment and management of funds and	
25	lapse date. All funds appropriated by this act shall	

1 be allotted, managed, administered and accounted for
2 in accordance with applicable laws, including, but not
3 limited to, the Financial Management Act of 1979. The
4 allottee shall be responsible for ensuring that these
5 funds, or so much thereof as may be necessary, are
6 used solely for the purpose specified in this act, and
7 that no obligations are incurred in excess of the sum
8 appropriated. The allottee of the funds appropriated
9 under subsection 1 of section 1 of this act shall be
10 the President of the Federated States of Micronesia or
11 his designee; PROVIDED THAT the allottee of funds
12 appropriated under subsections 1(b)(i) and 1(b)(ii) of
13 this act shall be the Mayor of Kolonia Town Government
14 or his designee; the allottee of funds appropriated
15 under subsections 1(b)(iii), 1(b)(vi) 1(d)(i) and
16 1(d)(ii) 1(d)(iii) of this act shall be the Pohnpei
17 Transportation Authority (PTA); the allottee of funds
18 appropriated under subsection 1(b)(v) of this act
19 shall be the Governor of the State of Pohnpei or his
20 designee. The allottee of funds appropriated under
21 subsection 2 of section 1 of this act shall be the
22 Governor of the State of Yap or his designee. The
23 authority of the allottee to obligate funds
24 appropriated by this act shall lapse on September 30,
25 2018."

PUBLIC LAW No. 19-128

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.


