**PUBLIC LAW No. 19-138**

AN ACT

To further amend Public Law No. 18-11, as amended by Public Laws Nos. 18-44, 18-81, 19-33, 19-106, 19-128 and 19-134, by amending sections 1 and 2 thereof, to change the use and allottee of funds previously appropriated for public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 1 of Public Law No. 18-11, as amended  
2 by Public Laws Nos. 18-44, 19-128 and 19-134, is hereby further  
3 amended to read as follows:

4               "Section 1. The sum of \$1,680,000, or so much thereof  
5 as may be necessary, is hereby appropriated from the  
6 General Fund of the Federated States of Micronesia for  
7 the fiscal year ending September 30, 2013, for the  
8 purpose of funding public projects and social programs  
9 in the states of Pohnpei and Yap. The funds shall be  
10 apportioned as follows:

11               (1) Pohnpei State ..... \$    1,130,000

12               PROVIDED, HOWEVER, that the funds appropriated in  
13 subsections (b)(c)(d) and (e) of this section shall  
14 not be allotted until Congress is officially advised  
15 that funds improperly disbursed as a result of the  
16 line item veto which was reflected in Public Law No.  
17 18-11 are collected.

 24 Public Laws Nos. 18-44, 18-81, 19-33 and 19-128, is  
 25 hereby further amended to read as follows:

1           "Section 2. Allotment and management of funds and  
2           lapse date. All funds appropriated by this act shall  
3           be allotted, managed, administered and accounted for  
4           in accordance with applicable laws, including, but not  
5           limited to, the Financial Management Act of 1979. The  
6           allottee shall be responsible for ensuring that these  
7           funds, or so much thereof as may be necessary, are  
8           used solely for the purpose specified in this act, and  
9           that no obligations are incurred in excess of the sum  
10          appropriated. The allottee of the funds appropriated  
11          under subsection 1 of section 1 of this act shall be  
12          the President of the Federated States of Micronesia or  
13          his designee; PROVIDED THAT the allottee of funds  
14          appropriated under subsections 1(b)(i) and 1(b)(ii) of  
15          this act shall be the Mayor of Kolonia Town Government  
16          or his designee; the allottee of funds appropriated  
17          under subsections 1(b)(iii), 1(b)(vi) 1(d)(i) and  
18          1(d)(ii) 1(d)(iii) of this act shall be the Pohnpei  
19          Transportation Authority (PTA); the allottee of funds  
20          appropriated under subsection 1(b)(v) of this act  
21          shall be the Governor of the State of Pohnpei or his  
22          designee; the allotte of funds appropriated under  
23          subsection 1(b)(vii) shall be the Secretary of the  
24          Department of Transportation, Communications and  
25          Infrastructure or his designee. The allottee of funds
