

AN ACT

To amend Sections 1 and 2 of P.L. No. 1-95, relating to appropriations from the General Fund for the purpose of building certain projects in the state of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 1-95 is hereby amended to
2 read as follows:

3 "Section 1. The sum of \$263,800, or so much thereof as may be
4 necessary, is hereby appropriated from the General Fund of the
5 Congress of the Federated States of Micronesia for the purpose
6 of funding certain public projects in the State of Truk. The
7 sum appropriated by this Section shall be apportioned in the
8 following manner:

9 (1) Moen Public Projects:

10 (a) Pis - Moen Seawall and repair of ferro-
11 cement boat \$10,000

12 (b) Fono seawall 10,000

13 (c) Classroom - Penia. 5,000

14 (2) Hall Weito and Patiw Public Projects:

16 (b) Puluwat Alei survey. 5,000

17 (c) Ruo dock 7,000

18 (d) Murilo Public Projects 1,800

19 (e) Pulusuk Public Projects. 3,000

20 (f) Pulap Public Projects. 3,000

4 Section 2. Section 2 of P.L. No. 1-95 is hereby amended to read as
5 follows:

6 "Section 2. The funds herein appropriated shall be administered
7 and managed in accordance with the provisions of the Financial
8 Management Act of 1979. Any part of this appropriation not
9 obligated as of September 30, 1981, shall revert to the General
10 Fund of the Federated States of Micronesia."

11 Section 3. This act shall become law upon approval by the President
12 of the Federated States of Micronesia, or upon its becoming law without
13 such approval.


