## AN ACT

## Public Law No. 1-1/0 CONGRESSIONAL BILL NO. 1-257, CD1

Federated States of Micronesia

1	Section 2. The funds appropriated and apportioned by Section 1 of
2	this act shall be administered, managed, and accounted for in accordance
3	with the Financial Management Act of 1979. The allottee of the funds
4	apportioned by Subsections (1), (2), (3), (4) and (5) of Section 1 shall
5	be the Governor of the state of Truk. The allottee of the funds appor-
6	tioned by Subsection (6) of Section 1 shall be the Director of Finance of
7	the Federated States of Micronesia. The funds apportioned by paragraphs
8	(f) through (1) of Subsection (3) of Section 1 and the funds apportioned
9	by paragraphs (a) and (b) of Subsection (4) of Section 1 shall not be
10	obligated until the relevant municipal government has submitted a document
11	identifying specific projects and the amounts required therefor, such
12	document reflecting the determinations of the chief magistrate and munici-
13	pal council of the relevant municipality, as indicated by the signature
14	of the chief magistrate.
15	Section 3. The authority to obligate funds appropriated by this act
16	shall lapse as of September 30, 1981.
17	Section 4. This act shall become law upon approval by the President
18	of the Federated States of Micronesia, or upon its becoming law without
19	such approval.
