To amend Public Law No. 1-97, which appropriated funds for certain public projects in the State of Ponape, to permit additional projects to be funded out of the sum appropriated, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 1 of Public Law No. 1-97 is hereby amended to

5	Section 2. Section 2 of Public Law No. 1-97 is hereby amended to read
6	as follows:
7	"Section 2. The funds herein appropriated shall be administered
8	and managed in accordance with the provisions of the Financial
9	Management Act of 1979, provided that line items (4), (5), (6)
10	and (7) shall not be obligated prior to August 1, 1980; provided
11	further, however, that no more than 25% of the funds apportioned
12	by paragraphs (c) and (d) of line item (5) may be obligated
13	immediately upon the effective date of this act. Any part of
14	this appropriation not obligated as of September 30, 1981, shall
15	revert to the General Fund of the Federated States of Micronesia."
16	Section 3. This act shall become law upon approval by the President
17	of the Federated States of Micronesia, or upon its becoming law without
18	such approval.
