CONGRESSIONAL BILL NO. 1-148, C.D.1

AN ACT

To appropriate the sum of \$405,000 from the General Fund of the Federated States of Micronesia to supplement the funds appropriated by Public Lew No. 1-21 for the Annual Budget of the government of the Federated States of Micronesia for fiscal year 1980, and for other purposes.

BE IT ENACTED BY THE COMGRESS OF THE PEDERATED STATES OF MICRONESIA:

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICHONESIA:
1	Section 1. The sum of \$405,000, or so much thereof as may be neces-
2	sary, is hereby appropriated from the General Fund of the Federated States
3	of Micronesia to supplement the funds appropriated by Public Lew No. 1-21
4	for the Annual Budget of the government of the Federated States of Micro-
5	nesia for fiscal year 1980. The sum appropriated by this act shall be
6	allocated as follows:
7	(1) Office of the President and Vice President \$ 60,000
8	(2) Executive Branch Operations
9	(3) FSM Contribution to the Micronesian Regional
10	Tourism Council
11	(4) Joint Delegation of the Federated States of
12	Micronesia to the U.N. Law of the Sea Conference
13	(5) Study Group on Indefinite Land Use Agreements 10,000.
14	Section 2. The sum appropriated by Section 1 of this act shall be
15	allotted by the Director of Finance to the appropriate designees of the
16	President of the Federated States of Micronesia, who shall be legally
27	responsible for the use, in the public interest, of the sum appropriated
18	by this Act in accordance with Public Law Mo. 1-45, and that no obligations
29	are incurred in excess of the sum appropriated. Any sum remaining
20	unabligated as of September 30, 1980 shall revert to the General Fund of
21	the Federated States of Micronesia.

Section 3. The President, by not later than 10 days after the convening

1	of the May regular session of the Congress, shall submit a detailed report
2	to the Congress of the Federated States of Micronesia, which shall provide
3	for full accounting by line item and by object class of the obligations, as
4	of March 31, 1980, incurred against the funds appropriated by this act,
5	present the planned use of such sums remaining unobligated as of March 31,
6	1980, and present the Annual Budget for the Federated States of Micronesia
7	for fiscal year 1981. The President may not exceed any line item in
8	Section 1 of this act by more than ten percent.
9	Section 4. Such sums as may be necessary, appropriated by Section 1
10	of this act, may be used for the salaries and official expenses of employees
11	of the government of the Federated States of Micronesia, provided that no
13	sum shall be used to hire unbudgeted employees. The following maximum
1.3	levels of permanent employees of the government of the Federated States
14	of Micronesia are hereby authorized:
