## AN ACT

To smend Sections 151, 152, and 153 of Chapter 3 of Title 33 of the Trust Territory Code, on Licensing of Copra Trade, and for other purposes.

## BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Sections 151, 152, and 153 of Chapter 3 of Title 33 of
- 2 the Trust Territory Code, on Licensing of Copra Trade, are hereby amended

- "(1) 'Section 151. Terms and Conditions of Licensure.
  - (a) The Director of Resources and Development of the Federated States of Micronesia shall administer the licensing process, including issuance, modification, restriction, suspension, and revocation of licenses, and supervision of licensees, for all persons, partnerships, associations, co-operatives or corporations purchasing copra for export either directly or through such agency as the Director of Resources and Development may approve.
  - (b) The Director of Resources and Development shall promulgate regulations and procedures controlling the issuance, modification, restriction, suspension or revocation of licenses, and the supervision of licensees under this Chapter.
  - (c) In the event of the denial, modification, restriction, suspension or revocation of a license under this Chapter, the party adversely affected may, within a 30 day period following receipt of notice by certified mail, appeal the decision of the Director of Resources and Development to the Board of
