A BILL FOR AN ACT

To appropriate the sum of \$2,800,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2018, for the purpose of funding public projects and social programs in the states of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$2,800,000, or so much thereof as may 2 be necessary, is hereby appropriated from the General Fund of the 3 Federated States of Micronesia for the fiscal year ending 4 September 30, 2018, for the purpose of funding public projects and 5 social programs in the states of Yap, Kosrae, Pohnpei and Chuuk. 6 The funds appropriated under this section shall be apportioned as 7 follows:

8 Section 2. Of the \$2,800,000 appropriated under this act, 9 \$400,000 shall be apportioned for public projects and social 10 programs in the state of Yap.

The allottee of the funds appropriated under subsections 4(1), 2 4(3) and 4(6) of this act shall be the Governor of Chuuk State or 3 his designee; the allottee of the funds appropriated under 4 5 subsection 4(2) of this act shall be the Mortlocks Island Development Authority (MIDA); the allottee of the funds 6 7 appropriated under subsection 4(4) of this act shall be the Southern Namoneas Development Authority; the allottee of the funds 8 appropriated under subsection 4(5) of this act shall be the 9 10 Faichuk Development Authority. The authority of the allottee to obligate funds appropriated by this act shall lapse on September 11 30, 2020. 12 13 Section 7.
