funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum The allottee of funds appropriated under appropriated. section 2 of this act shall be the Governor of Yap State or his designee. The allottee of the funds appropriated under sections 3 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; PROVIDED THAT the allottee of funds appropriated under subsections 3(a) to 3(o) of this act shall be the Mayor of Lelu Town Government or his designee; the allottee of funds appropriated under subsections 3(p) to $[\frac{3(ad)}{1}]$ 3(ae) of this act shall be the Mayor of Tafunsak Municipal Government or his designee; the allottee of funds appropriated under subsections 4(2)(e), 4(2)(g) and 4(2)(m) of this act shall be the Pohnpei Transportation Authority (PTA); the allottee of funds appropriated under subsection 4(2)(o) of this act shall be the Pohnpei Utility Corporation (PUC). The allottee of the funds appropriated under subsections 5(1), 5(3) and 6(6) of this act shall be the Governor of Chuuk State or his designee; the allottee of the funds appropriated under subsection 5(2) of this act shall be the Mortlocks Island Development Authority (MIDA); the allottee of the funds appropriated under
