A BILL FOR AN ACT

To amend Public Law No. 20-93, by amending section 1 thereof, to change the use of funds previously appropriated, to fund priority infrastructure projects and public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
