A BILL FOR AN ACT

To amend title 20 of the Code of the Federated States of Micronesia (Annotated), by creating a new chapter 15, in order to establish rules on competition and anti-dumping in air services, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Title 20 of the Code of the Federated States of
- 2 Micronesia (Annotated), is hereby amended by creating a new
- 3 chapter 15 entitled: "Fair Competition".
- 4 Section 2. Title 20 of the Code of the Federated States of
- 5 Micronesia (Annotated), is hereby amended by inserting a new
- 6 section 1501 under chapter 15 to read as follows:
- 7 "Section 1501. Statement of Policy. It is hereby
- 8 declared to be the policy of the Federated States of
- 9 Micronesia:
- 10 (1) That all people have the right to access to
- 11 quality, safe, effective and affordable air
- 12 transportation services;
- 13 (2) That whereas competition is encouraged, unfair
- 14 practices that undermine competition are strictly
- prohibited and shall be stopped; and
- 16 (3) That the Secretary of Transportation
- 17 Communication and Infrastructure shall regulate and
- 18 oversee air transportation in the Federated States of

Micronesia in order to ensure fair competition and to 1 2 void unfair practices that are deleterious to the 3 public." 4 Section 3. Title 20 of the Code of the Federated States of 5 Micronesia (Annotated), is hereby amended by inserting a new section 1502 under chapter 15 to read as follows: 6 7 "Section 1502. Anti-dumping. 8 (1) Dumping of air transport products and services is 9 prohibited. The Secretary may recommend to the 10 President the imposition of an anti-dumping duty 11 whenever circumstance warrant its imposition. The amount of anti-dumping duty, and the administrative 12 13 details of its implementation, shall be approved by 14 regulation. The duty, if applicable, shall be applied 15 against any dumped product whose release for free 16 circulation in the Federated States of Micronesia causes 17 injury. 18 (2) A product or services is considered as being 19 dumped it its export price to the Federated states of 20 Micronesia is less than a comparable price for the like product, in the ordinary course of trade, as established 21 22 for the exporting country. 23 (3) In order to determine administratively if a 24 product is dumped, the Secretary shall review pricing of 25 products and services and may order any person or entity

1	to produce document, record, or explanation to justify
2	price of products and services. The Secretary may
3	employ the services of experts to assist him in
4	enforcing this anti-dumping act, including the review of
5	pricing to determine whether products and services are
6	dumped.
7	(4) The Secretary may issue regulation in accordance
8	with the Administration Procedures Act to implement this
9	section. Such regulation shall provide for
10	administrative procedures, remedies and due process in
11	determining whether certain produces are dumped. Such
12	regulation once promulgated shall have the force and
13	effect of law."
14	Section 4. This act shall become law upon approval by the
15	President of the Federated States of Micronesia or upon its
16	becoming law without such approval.
