A BILL FOR AN ACT

To further amend Public Law No. 19-54, as amended by Public Laws Nos. 19-62, 19-75, 19-79, 19-99, 19-119 and 20-04, by amending section 6 thereof, to change the lapse date of funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 19-54, as amended by
- 2 Public Laws Nos. 19-62, 19-75, 19-99, 19-129 and 20-04, is hereby
- 3 further amended to read as follows:

4 "Section 6. Allotment and management of funds and lapse 5 date. All fund appropriated by this act shall be 6 allotted, managed, administered and accounted for in 7 accordance with applicable laws including, but not 8 limited to, the applicable laws, including, but not 9 limited to, the Financial Management Act of 1979. 10 allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used 11 solely for the purpose specified in this act, and that 12 13 no obligations are incurred in excess of the sum 14 appropriated. The allottee of the funds appropriated under section 2 of this act shall be the Governor of Yap 15 16 The allottee of funds appropriated under sections 3 and 4 of this act shall be the President of 17 18 the Federated States of Micronesia or his designee;

PROVIDED THAT, the allottee of funds appropriated under 1 2 subsections 3(a), (b), (c), (d), (e), (f), (q), (h), 3 (t), (u), (v), (ag), (ar) and (as) of this act shall be 4 the Mayor of Utwe Municipal Government or his designee; 5 the allottee of funds appropriated under subsections 6 3(k), (w), (x), (y), (z), (aa), (ab), (ac), (ad), (ae), 7 (af), (ah), (ai), (aj), (ak), (al), (am), (an), (ao), (ap) and (aq) of this act shall be the Mayor of Tafunsak 8 Municipal Government or his designee; the allottee of 9 10 funds appropriate under subsections ((1)(a), (b), (c), 11 (e), (f), and 4(2) shall be the Secretary of the Department of Transportation, Communications and 12 13 Infrastructure or his designee; he allottee of funds 14 appropriated under subsections 4(1)(d), 4(3)(b), 4(3)(d), 4(3)(e), 4(3)(h), 4(3)(k) and 4(3)(1) shall be 15 16 the Pohnpei Transportation Authority (PTA). allottee of funds appropriated under subsections 5(1), 17 18 5(3) and 5(6) of this act shall be the Governor of Chuuk 19 State or his designee. The allottee of funds 20 appropriated under subsection 5(2) of this act shall be 21 the Mortlock Islands Development Authority. 22 allottee of funds appropriated under subsection 5(4) of this act shall be the Southern Namoneas Development 23 Authority. The allottee of funds appropriated under 24 subsection 5(5) of this act shall be the Faichuk 25
