## A BILL FOR AN ACT

To further amend section 12 of Public Law No. 20-42, as amended by Public Law Nos. 20-64, 20-67, 20-83, 20-94 and 20-103 to designate a new allottee for a certain line item, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 12 of Public Law No. 20-42, as amended
- 2 by Public Law Nos. 20-64, 20-67, and 20-83, is hereby further
- 3 amended to read as follows:
- 4 "Section 12. Allotment and Management of Funds and
- 5 Lapse Dates.
- 6 (1) General provisions.
- 7 (a) All funds appropriated by this act shall be
- 8 allotted, managed, administered and accounted for in accordance
- 9 with applicable law, including, but not limited to, the
- 10 Financial Management Act of 1979.
- 11 (b) The allottees shall be responsible for ensuring
- 12 that these funds, or so much thereof as may be necessary, are
- 13 used solely for the purposes specified in this act, and that no
- 14 obligations are incurred in excess of the sums appropriated.
- 15 (2) Allottees. The allottees of the funds appropriated by
- 16 this act are as follows:
- 17 (a) Section 2 the allottee of these funds shall be the
- 18 President of the Federated States of Micronesia;
- 19 (b) Section 3 the allottee of these funds shall be the

- 1 Speaker of the Congress of the Federated States of Micronesia;
- 2 (c) Section 4 the allottee of these funds shall be the
- 3 Chief Justice of the Supreme Court of the Federated States of
- 4 Micronesia;
- 5 (d) Section 5 the allottee of these funds shall be the
- 6 Public Auditor of the Federated States of Micronesia;
- 7 (e) Sections 6 through 9 the allottee of these funds
- 8 shall be the President of the Federated States of Micronesia;
- 9 PROVIDED, HOWEVER, that for the following subsections of
- 10 sections 8 through 9 of this act:
- (i) Section 8(1)(g) the allottee of these funds
- 12 shall be the Chair of the Joint Committee on Compact Review and
- 13 Planning;
- 14 (ii) Section 8(9) the allottee of these funds shall
- 15 be the Speaker of the Congress of the Federated States of
- 16 Micronesia;
- 17 (iii) Section 8(12)(a) the allottee of these funds
- 18 shall be the President of the College of Micronesia-FSM;
- 19 (iv) Section 8(12)(e) through (h) the allottee of
- 20 these funds shall be the Chief Justice of the respective State
- 21 Supreme Court;
- 22 (v) Section 9(1) the allottee of these funds shall
- 23 be the President of the College of Micronesia-FSM;
- 24 (vi) Section 9(16)(a) the allottee of these funds
- 25 shall be the President of the Federated States of Micronesia;

- 1 EXCEPT THAT, for the share of funds from this line item for the
- 2 Conservation Society in Chuuk, the allottee shall be the
- 3 Governor of the State of Chuuk, AND, for the share of funds from
- 4 this line item for the Conservation Society in Yap, the allottee
- 5 shall be the Governor of the State of Yap, AND, for the share of
- 6 funds from this line item for the Conservation Society in
- 7 Kosrae, the allottee shall be the Kosrae Civil Society;
- 8 (vii) Section 9(16)(f) the allottee of these funds
- 9 shall be the Governor of the State of Yap;
- 10 (viii) Section 8(12)(v) through (y) the allottee of
- 11 these funds shall be the Governor of the respective State.
- 12 (ix) Section 8(6)(j) the allottee of funds shall be
- 13 the FSM Embassy, Beijing, China;
- 14 (x) Section 8(6)(k) the allottee of these funds
- 15 shall be the FSM Embassy, Suva, Fiji;
- 16 (xi) Section 8(12)(z) the allottee of these funds
- 17 shall be the Governor of the State of Yap;
- 18 (xii) Section 9(4)(q) the allottee of these funds
- 19 shall be the Open Access Entity.
- 20 (3) Lapse date. The authority of the allottees to obligate
- 21 funds appropriated by this act shall lapse as of September 30,
- 22 2018; PROVIDED, HOWEVER, that the funds appropriated under
- 23 section 9 of this act shall not lapse."
