A BILL FOR AN ACT

To further amend Public Law No. 20-31, as amended by Public Laws Nos. 20-41, 20-50, 20-77 and 20-113, by amending sections 4 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

All funds appropriated by this act 24 shall be allotted, managed, administered and 25

1 accounted for in accordance with applicable laws, 2 including, but not limited to, the Financial 3 Management Act of 1979. The allottee shall be responsible for ensuring that these funds, or so 4 much thereof as may be necessary, are used solely 5 6 for the purpose specified in this act, and that no 7 obligations are incurred in excess of the sum appropriated. The allottee of the funds 8 9 appropriated under section 2 of this act shall be 10 the Governor of Yap State or his designee. The allottee of funds appropriated under sections 3 and 11 12 4 of this act shall be the President of the 13 Federated States of Micronesia or his designee; 14 PROVIDED THAT the allottee of funds appropriated under subsections 3(a) to 3(n) of this act shall be 15 the Mayor of Lelu Town Government or his designee; 16 17 the allottee of funds appropriated under subsections 3(o) to 3(ae) of this act shall be the 18 Mayor of Tafunsak Municipal Government or his 19 20 designee; the allottee of funds appropriated under 21 subsections 4(1)(f), 4(1)(k), 4(1)(1), 4(1)(m), 22 4(2)(b) and 4(2)(c) of this act shall be the Pohnpei Transportation Authority (PTA); the 23 24 allottee of funds appropriated under subsections 4(2)(a), 4(2)(d), 4(2)(e), 4(2)(f), 4(2)(g), 25

1 4(2)(h), 4(2)(i) [and], 4(2)(j) and 4(3)(o) shall 2 be the Secretary of the Department of 3 Transportation, Communications and Infrastructure or his designee; 4(3)(g), 4(3)(v) and 4(3)(w) of 4 this act shall be the Secretary of Education or his 5 6 designee; the allottee of funds appropriated under 7 subsections 4(3)(j), 4(3)(1) and 4(3)(t) of this act shall be the Luhkenmoanlap of Kitti; [the 8 9 allottee of funds appropriated under subsection 4(3)(0) of this act shall be the Pohnpei Utility 10 Corporation; the allottee of funds appropriated 11 12 under subsection 4(3)(p) of this act shall be the Director of Land Grant Program; the allottee of 13 14 funds appropriated under subsection 4(3)(r) of this act shall be the Secretary of Health and Social 15 16 Affairs or her designee; the allottee of funds 17 appropriated under subsection 4(3)(u) of this act shall be the Meninkeder of Madolenihmw. 18 allottee of funds appropriated under subsections 19 20 5(1), 5(3) and 5(6) of this act shall be the 21 Governor of Chuuk State or his designee. 22 allottee of funds appropriated under subsection 5(2) of this act shall be the Mortlock Islands 23 Development Authority. The allottee of funds 24 appropriated under subsection 5(4) of this act 25
