## A BILL FOR AN ACT

To further amend Public Law No. 16-62, as amended by Public Laws Nos. 16-71, 17-05, 17-18, 17-29, 17-47, 18-23, 18-33, 18-50, 18-79, 19-19 19-44 and 19-111, by amending section 6 thereof, to change lapse date of certain funds previously appropriated therein, to fund public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 16-62, as amended by 2 Public Laws Nos. 16-71, 17-05, 17-18, 18-23, 18-79, 19-19 and 19-111, is hereby further amended to read as follows: 3 "Section 6. Allotment and management of funds and 4 5 lapse date. All funds appropriated by this act shall be allotted, managed, administered and accounted for 6 in accordance with applicable law, including, but not 7 8 limited to, the Financial Management Act of 1979. 9 The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, 10 11 are used solely for the purpose specified in this 12 act, and that no obligations are incurred in excess 13 of the sum appropriated. The allottee of funds appropriated under sections 2 and 4 of this act shall 14 15 be the President of the Federated States of 16 Micronesia or his designee; PROVIDED THAT, the allottee of funds appropriated under subsection 17

4(1)(c) of this act shall be the Pohnpei 1 2 Transportation Authority, the allottee of funds 3 appropriated under subsection 4(2)(c) of this act 4 shall be the Secretary of the Department of Resources 5 and Development or his designee, the allottee of 6 funds appropriated under subsections 4(3)(b), 4(3)(c)7 and 4(3)(j) of this act shall be the Luhkenmoanlap of 8 Kitti Municipal Government and the allottee of funds appropriated under subsection 4(3)(i) of this act 9 shall be the Meninkeder Lapalap of Madolenihmw 10 11 Municipal Government. The allottee of funds 12 appropriated under section 3 of this act shall be the 13 Governor of Yap State. The allottee of funds 14 appropriated under subsections 5(1), 5(3) and 5(6) 15 shall be the Governor of Chuuk or his designee. The 16 allottee of funds appropriated under subsection 5(2) 17 of this section 5 of this act shall be the Mortlocks 18 Islands Development Authority. The allottee of funds 19 appropriated under subsection 5(4) of section 5 of 20 this act shall be the Executive Director of the 21 Southern Namoneas Development Authority. The 22 allottee of funds appropriated under subsection 5(5) 23 of section 5 of this act shall be the Faichuk 24 Development Authority. The funds appropriated by 25 this act shall lapse on September 30, [2018] 2019."
