A BILL FOR AN ACT

To amend sections 1 and 12 of Public Law No. 20-42, as amended by Public Laws Nos. 20-54, 20-64 and 20-67, in order to appropriate the sum of \$200,100.70 of additional funds from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2018, to fund the operation of the Project Management Unit (PMU) under the Department of Transportation Communications & Infrastructure for the remainder of the fiscal year, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Purpose. The sum of \$200,100.70 is hereby
- 2 appropriate from the General Fund of the Federated States of
- 3 Micronesia for the fiscal year ending September 30, 2018, for the
- 4 purpose of funding the operations of Project Management Unit (PMU)
- 5 under the Department of Transportation Communications and
- 6 Infrastructure for the remainder of the fiscal year. The amount
- 7 appropriate herein is the remainder of the total approved budget
- 8 for PMU's Fiscal Year 2018 Operations Budget.
- 9 Section 2. Section 12 of Public Law No. 20-42, as amended by
- 10 Public Laws Nos. 20-67, is hereby amended to read as follows:
- "Section 12. Allotment and Management of Funds and Lapse
- 12 Dates.
- 13 (1) General provisions.
- 14 (a) All funds appropriated by this act shall be
- 15 allotted, managed, administered and accounted for in
- 16 accordance with applicable law, including, but not limited
- to, the Financial Management Act of 1979.

1	(b) The allottees shall be responsible for ensuring
2	that these funds, or so much thereof as may be necessary,
3	are used solely for the purposes specified in this act, and
4	that no obligations are incurred in excess of the sums
5	appropriated.
6	(2) $\underline{\text{Allottees}}$. The allottees of the funds appropriated
7	by this act are as follows:
8	(a) The allottee of funds appropriated under this act
9	shall be the President. The authority of the allottee
10	under this act may be sub-allotted to the Department of
11	Transportation, Communications and Infrastructure.
12	(3) Lapse date. The authority of the allottees to
13	obligate funds appropriated by this act shall not lapse
14	until fully expended."
15	Section 3. This act shall become law upon approval by the
16	President of the Federated States of Micronesia or upon its
17	becoming law without such approval.
