## A BILL FOR AN ACT

To further amend Public Law No. 19-141, as amended by Public Laws Nos. 19-147 and 19-171, by amending section 1 thereof, to change the use of fund previously appropriated therein for the purpose of funding public projects and social programs for the people of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 1 of Public Law No. 19-141, as amended by 2 Public Laws Nos 19-147 and 19-171, is hereby further amended to 3 read as follows: 4 "Section 1. Title. To appropriate the sum of \$700,000 from

5 the General Fund of the Federated States of Micronesia for the 6 fiscal year ending September 30, 2017, for the purpose of funding 7 the defunded programs and activities of the government of the 8 state of Kosrae and to fund public projects and social programs 9 for the people of Chuuk. The sum appropriated herein shall be 10 apportioned as follows:
