PUBLIC LAW NO. 20-93

AN ACT

To appropriate the sum of \$800,000, or so much thereof as may be necessary, from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2018, previously appropriated to fund priority infrastructure projects for the state of Kosrae, to fund public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$800,000, or so much thereof as
2	may be necessary, is hereby appropriated from the General
3	Fund of the Federated States of Micronesia for the fiscal
4	year ending September 30, 2018, previously appropriated to
5	fund priority infrastructure projects for the state of
6	Kosrae, to fund public projects and social programs in the
7	state of Kosrae. The funds appropriated under this section
8	shall be apportioned as follows:
