#### AN ACT

To further amend title 24 of the Code of the Federated States of Micronesia (Annotated), as amended, by creating a new chapter 12 to establish the Vessel Day Scheme Acquisition Fund, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Policy statement. It is the intent of this act
- 2 to strengthen the mandate of the National Oceanic Resources
- 3 Management Authority (NORMA) to manage, administer and exploit
- 4 fisheries resources. At the same time, mindful of the potential
- 5 revenue associated with favorable and unpredictable fishing
- 6 conditions under the Vessel Day Scheme (VDS), it is the sense of
- 7 the Congress of the Federated States of Micronesia that a VDS
- 8 Revolving Fund established by this act could leverage the further
- 9 maximization of revenue from fisheries through the trading of
- 10 vessel days in the manner consistent with the prevailing practices
- 11 among the PNA members.
- 12 Section 2. Title 24 of the Code of the Federated States of
- 13 Micronesian (Annotated), as amended, is hereby further amended by
- 14 creating a new chapter 12 entitled:
- "Chapter 12. Vessel Day Scheme Acquisition Fund".
- 16 Section 3. Chapter 12 of title 24 of the Code of the
- 17 Federated States of Micronesian (Annotated), as amended, is hereby
- 18 amended by inserting a new section 1201 to read as follows:
- 19 "Section 1201. <u>Establishment</u>. There is hereby created

1	and established the Vessel Day Scheme (VDS) Acquisition
2	Fund, hereinafter referred to as the "VDS Acquisition
3	Fund", separate from the General Fund of the Federated
4	States of Micronesia and all other funds."
5	Section 4. Chapter 12 of title 24 of the Code of the
6	Federated States of Micronesia (Annotated), as amended, is hereby
7	amended by inserting a new section 1202 to read as follows:
8	"Section 1202. Purpose.
9	To provide the legal and financial authority of the
10	National Oceanic Resources Management Authority to
11	purchase vessel days from members of the Parties to the
12	Nauru Agreement (PNA) who are Parties to the Palau
13	Arrangement Vessel Day Scheme (VDS Participants) for the
14	purpose of re-selling the vessel days to interested
15	parties who hold valid fishing access agreements with
16	the National Oceanic Resource Management Authority for
17	the purpose of generating revenue or maximizing economic
18	benefit for the Federated States of Micronesia. The
19	Fund shall be used exclusively to purchase vessel days."
20	Section 5. Chapter 12 of title 24 of the Code of the
21	Federated States of Micronesia (Annotated), as amended, is hereby
22	amended by inserting a new section 1203 to read as follow:
23	"Section 1203. Acquisition of vessel days
24	To maximize fishing opportunities, the Board of
2 5	Directors may authorize the Executive Director to use

1	funding in the VDS Acquisition Fund to secure additional							
2	fishing days from PNA members as provided by the Palau							
3	Arrangement."							
4	Section 6. Chapter 12 of title 24 of the Code of the							
5	Federated States of Micronesia (Annotated), as amended, is hereby							
6	amended by inserting a new section 1204 to read as follows:							
7	"Section 1204. Deposits.							
8	All future appropriations for the Fund shall be							
9	deposited in the Fund. The total amount of the fund							
10	shall be limited to \$3,000,000. All revenues generated							
11	and any unexpended moneys in excess of \$3,000,000 shall							
12	be paid into the General Fund."							
13	Section 7. Chapter 12 of title 24 of the Code of the							
14	Federated States of Micronesia (Annotated), as amended, is hereby							
15	amended by inserting a new section 1205 to chapter 12 to read as							
16	follows:							
17	"Section 1205. Administration.							
18	The Fund shall be administered by the President of the							
19	Federated States of Micronesia or his designee, who							
20	shall establish procedures necessary and appropriate for							
21	the effectuation and implementation of the provisions of							
22	this chapter."							
23	Section 8. Chapter 12 of title 24 of the Code of the							
	Federated States of Micronesia (Annotated), as amended, is hereby							
25	amended by inserting a new section 1206 to read as follows:							

1	"Section 1206. Annual Report.
2	The President or his designee shall report to the
3	Congress of the Federated States of Micronesia on the
4	status of the Fund at the close of each fiscal year."
5	Section 9. Chapter 12 of title 24 of the Code of the
6	Federated States of Micronesia (Annotated), as amended, is hereby
7	amended by inserting a new section 1207 to read as follows:
8	"Section 1207. Regulation. With the approval of the
9	President, the Authority shall promulgate appropriate
10	regulation in accordance with the Administrative
11	Procedures Act, providing for suitable policy concerning
12	the trading of vessel days and such controls that shall
13	govern the management of the revolving fund in
14	accordance with the Financial Management Act."
