

CONGRESSIONAL BILL NO. 20-303

AN ACT

To further amend Public Law No. 20-92, as amended by Public Laws Nos. 20-124 and 20-161, by amending section 2 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs in the state of Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 2 of Public Law No. 20-92, as amended by
