- 1 WHEREAS, section 104 of title 55 of the Code of the

- 3 requires that Congress adopt a resolution setting forth the
- 4 total funds to be available from the General Fund and any
- 5 special funds of the Treasury of the Federated States of
- 6 Micronesia for each fiscal year; now, therefore
- 7 BE IT RESOLVED by the Twentieth Congress of the Federated
- 8 States of Micronesia, Fifth Regular Session, 2018, that the
- 9 amount estimated to be available for the fiscal year ending
- 10 September 30, 2019, is set at \$79,656,878 of which \$77,044,255
- 11 is from domestic revenues, and \$1,000,000 will be available
- 12 from the Amended Compact sector grant and \$1,612,623 will be
- 13 available from the Supplemental Education Grant; and
