- 3 requires that Congress adopt a resolution setting forth the
- 4 total funds estimated to be available from the General Fund and

- 11 is from domestic revenues, and \$9,545,500 will be available
- 12 from amended Compact Sector for COM-FSM and \$2,168,694 will be
- 13 available from the Supplemental Education Grant; and
