CONGRESSIONAL RESOLUTION NO. 20-26

A RESOLUTION

Approving and accepting a grant in the amount of \$400,991 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to fund the Federated States of Micronesia Communicable Disease Prevention and Control Project, for the budget period from January 01, 2017, to December 31, 2017, including all the terms and conditions of the assistance.

1 WHEREAS, the United States through the Department of Health
2 and Human Services, Centers for Disease Control and Prevention,
3 issued a second Notice of Award of financial assistance on July
4 14, 2017, in the amount of \$400,991; and

5 WHEREAS, the purpose of the grant is to continue funding the
6 project entitled: "FSM Communicable Disease Prevention and
7 Control" including the program's personnel salaries, operational
8 cost, supplies, contractual services, and other expenses; and

9 WHEREAS, section 210 (2) of title 55 of the Code of the
10 Federated States of Micronesia provides that for an agreement on
11 foreign financial assistance to be valid it must be approved by
12 Congress by resolution; and

13 WHEREAS, the FSM Government expresses appreciation to the
14 U.S. Government for the federal grant programs made available to
15 the Federated States of Micronesia; now, therefore

16 BE IT RESOLVED by the Twentieth Congress of the Federated
17 States of Micronesia, Second Regular Session, 2017, that Congress
18 hereby approves and accepts the \$400,991 grant from the U.S.

1 Department of Health and Human Services, Centers for Disease
2 Control and Prevention, to fund the FSM Communicable Disease
3 Prevention and Central Project, including all the terms and
4 conditions thereof; and

5 BE IT FURTHER RESOLVED that certified copies of this
6 resolution be transmitted to the President of the Federated States
7 of Micronesia, the Secretary of the Department of Health and
8 Social Affairs, and the United States Embassy in Kolonia.




