A RESOLUTION

Approving and accepting a grant in the amount of \$248,000 from the U.S. Department of Health and Human Services, to fund the Universal Newborn Hearing Screening and Intervention Project, including all the terms and conditions of the assistance.

1 WHEREAS, on February 19, 2019, the U.S. Department of Health
2 and Human Services issued a Grant Award to the Federated States of
3 Micronesia in the amount of \$248,000, to fund the Universal
4 Newborn Hearing Screening and Intervention Project; and

5 WHEREAS, section 210(2) of title 55 of the Code of the
6 Federated States of Micronesia (Annotated), as amended, provides
7 that for financial assistance to be valid it must be approved by
8 Congress by resolution; now, therefore,

9 BE IT RESOLVED by the Twentieth Congress of the Federated
10 States of Micronesia, Seventh Special Session, 2019, that Congress
11 hereby approves and accepts the \$248,000 grant from the U.S.
12 Department of Health and Human Services, to fund the Universal
13 Newborn Hearing Screening and Intervention Project, including all
14 the terms and conditions thereof; and
