CONGRESSIONAL RESOLUTION NO. 20-193

A RESOLUTION

Approving and accepting a grant in the amount of \$74,975 from the United Nations Educational, Scientific and Cultural Organization, to provide funding for various projects of the Federated States of Micronesia under the Participation Programme for 2018-2019, including all the terms and conditions of the assistance.

1 WHEREAS, the United Nations Educational, Scientific and
2 Cultural Organization (UNESCO) is providing a grant in the amount
3 of \$74,975, which has been received by the FSM Treasury; and

4 WHEREAS, this grant is to be used to support various projects
5 of the Federated States of Micronesia under the Participation
6 Programme for 2018-2019; and

7 WHEREAS, section 210(2) of title 55 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, requires
9 that for foreign financial assistance to be valid it must be
10 approved by Congress by resolution; now, therefore,

11 BE IT RESOLVED by the Twentieth Congress of the Federated
12 States of Micronesia, Seventh Special Session, 2019, that Congress
13 hereby approves the \$74,975 grant from UNESCO including all the
14 terms and conditions thereof; and


