input of the state leadership as they administer the programs.

The proposed grant award will support our Nation's family planning divisions in all the four states. There is also funding under this grant that will be used by the states to fund activities at the State COM-FSM campuses. This grant is well known to the Committee, and your Committee appreciates the information regarding this program that it received in August 2017. The Family Planning Program funded by this grant is very important for our Nation, and the health and well being of women of childbearing age. It is noted by your Committee that according to information provided by the Department of Health and Social Affairs that approximately all women of child bearing age report that they use some type of family planning. The proposed grant will provide birth control, and this is itemized in the attached budget as "Other" for \$183,000.

The Committee did question why the budgets for the four states were not in proportion to their populations. The Department responded that the state's developed their own budget and priority activities.

Your Committee also inquired as to the declining population in the FSM, did the Department believe that the family planning program have anything to do with that. The Department responded that the current generation of young women are having four children, as compared to the previous generation where women were having eight children. It is difficult to tell exactly the effect of family planning on the population of the Nation as many of our citizens are leaving for the U.S., however, it is probably safe to say that assess to birth control is playing a part in the decline.
