representatives the Department of Justice. Your Committee was also fortunate to have the Directors of the State Hospitals of Pohnpei and Kosrae, at this hearing. Your Committee values the input of the state leadership as they administer the programs.

The program that this proposed grant supports is well known to the Committee, and it believes that the work done in this area is important due to the large number of our citizens that continue to suffer from cancer. It is therefore, very concerned to hear from the Department of Health and Social Affairs that for the coming grant year the proposed funding has been cut by over half. The Department has advised the Committee that this is through no fault of the program or its administrators, but the decrease in funding was an administrative decision on the U.S. side.

When the Committee inquired as to how the decrease in funding would affect the program the Department was very forthright and stated that less service would be offered in the coming years. Going forward the program will have to chose one or two project items to emphasize per year. While it hopes that funding will be restored in the future it must prioritize for this next year. The Department also stated that it did retain all of the employees in the program as they are important for implementation and it would be more challenging to recruit skilled people later if the funding was restored.

As to the activities and performance of this program the Department stated that oral, or mouth, cancer was on the rise due to increasing use of tabacco with betel nut. The Committee was advised that multi-year statistics regarding the number of our citizens suffering from various types of cancers has been collected. The Committee requested that this survey be provided, as well as, the most recent program report.
