Your Committee remains strongly committed to all work to reduce the major diseases affecting the citizens of our Nation. The overall program funded by this grant is well known to the Committee, and has been a part of the FSM preventative health program for many years.

Notwithstanding the above comments, it is therefore, for the reasons set forth above, your Committee on Health and Social Affairs supports the grant activities proposed to be funded, it is in accord with the intent and purpose of C.R. No.20-64, and recommends its adoption in the form attached hereto.
