Your Committee held a meeting with representatives from the Department of Finance and Administration and the Department of Justice on Friday, December 8, 2017, at 8:30 a.m. to discuss this resolution. At this meeting, the Secretary of Finance and Administration, along with her key staff, provided your Committee with an overview of the purpose of the resolution.

Your Committee heard testimony from the Department of Finance and Administration that the grant funding in this resolution would support the preparation efforts for the World Bank IDA18 projects in the Federated States of Micronesia. These projects are planned to target multiple development areas within the FSM, including Energy, Information and Communications Technology (ICT), Maritime and Fisheries, and Financial Management Information Systems.

Your Committee asked the Department of Finance whether the FSM National Government had the "capacity" to meet the project requirements for this grant funding. Your Committee was assured that the National Government did have this capacity. Your Committee asked about whether the World Bank projects proposed under this grant funding would require large numbers of foreign consultants. Your Committee was told that this grant package would emphasize "capacity-building" within the FSM rather than the hiring of temporary foreign workers.

Your Committee asked the representative from the Department of Justice to voice his opinion on the legal sufficiency of the resolution. The Department of Justice reported that the resolution, as drafted, had full legal sufficiency. The Department of Justice confirmed that, while the resolution did commit the FSM National Government to certain legal obligations, the resolution itself was not legally problematic or exceptional.

After the 8:30 a.m. meeting that took place on December 8<sup>th</sup>, your Committee held a separate internal Committee Meeting to discuss the merits of this resolution. Your Committee evaluated the information presented at the earlier meeting and reviewed supporting documentation provided by the Department of Finance and
