Your Committee on Ways & Means, to which was referred Presidential Communication 20-247, regarding the line item vetoes of Congressional Act 20-90, entitled:

"AN ACT TO APPROPRIATE THE SUM OF \$1,400,000 FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2018, FOR THE PURPOSE OF FUNDING PUBLIC PROJECTS AND SOCIAL PROGRAMS FOR THE PEOPLE OF YAP, KOSRAE, POHNPEI AND CHUUK STATES, AND FOR OTHER PURPOSES.",
