## A BILL FOR AN ACT

To further amend Public Law No. 19-54, as amended by Public Laws Nos. 19-62, 19-75, 19-79, 19-99, 19-119, 20-04, 20-56, 20-82, 20-127 and 21-20, by amending section 6 thereof, to change the allottee and lapse date of funds previously appropriated therein, to fund public projects and social programs for Chuuk State, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 19-54, as amended by 2 Public Laws Nos. 19-62, 19-75, 19-99, 19-129, 20-04, 20-127 and 3 21-20, is hereby further amended to read as follows: 4 "Section 6. Allotment and management of funds and lapse date. All fund appropriated by this act shall be 5 allotted, managed, administered and accounted for in 6 accordance with applicable laws including, but not 7 limited to, the applicable laws, including, but not 8 9 limited to, the Financial Management Act of 1979. The allottee shall be responsible for ensuring that these 10 11 funds, or so much thereof as may be necessary, are used 12 solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum 13 14 appropriated. The allottee of the funds appropriated 15 under section 2 of this act shall be the Governor of Yap The allottee of funds appropriated under 16 State. sections 3 and 4 of this act shall be the President of 17 the Federated States of Micronesia or his designee; 18

1	PROVIDED THAT, the allottee of funds appropriated under
2	subsections 3(a), (b), (c), (d), (e), (f), (g), (h),
3	(t), (u), (v), (ag), (ar) and (as) of this act shall be
4	the Mayor of Utwe Municipal Government or his designee;
5	the allottee of funds appropriated under subsections
6	3(k), (w), (x), (y), (z), (aa), (ab), (ac), (ad), (ae),
7	(af), (ah), (ai), (aj), (ak), (al), (am), (an),(ao),
8	(ap) and (aq) of this act shall be the Mayor of Tafunsak
9	Municipal Government or his designee; the allottee of
10	funds appropriate under subsections ((1)(a), (b), (c),
11	(e), (f), and 4(2) shall be the Secretary of the
12	Department of Transportation, Communications and
13	Infrastructure or his designee; he allottee of funds
14	appropriated under subsections 4(1)(d), 4(3)(b),
15	4(3)(d), 4(3)(e), 4(3)(h), 4(3)(k) and 4(3)(1) shall be
16	the Pohnpei Transportation Authority (PTA). The
17	allottee of funds appropriated under subsections 5(1)[ $ au$
18	$\frac{5(3)}{3}$ ] and 5(6) of this act shall be the Governor of
19	Chuuk State or his designee. The allottee of funds
20	appropriated under subsection 5(2) of this act shall be
21	the Mortlock Islands Development Authority. <u>The</u>
22	allottee of funds appropriated under subsection 5(3) of
23	this act shall be the Mayor of Weno Municipal Government
24	or his designee. The allottee of funds appropriated
25	under subsection 5(4) of this act shall be the Southern

1	Namoneas Development Authority. The allottee of funds
2	appropriated under subsection 5(5) of this act shall be
3	the Faichuk Development Authority. The authority of the
4	allottee to obligate funds appropriated by this act
5	shall lapse on September 30, [ <del>2020</del> ] <u>2022</u> ."
6	Section 2. This act shall become law upon approval by the
7	President of the Federated States of Micronesia or upon its
8	becoming law without such approval.
