A BILL FOR AN ACT

To appropriate the sum of \$2,100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2020, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

The allottee of the funds appropriated under subsections 5(1) and 10 5(6) of this act shall be the Governor of Chuuk State or his 11 12 designee; the allottee of the funds appropriated under 13 subsection 5(2) of this act shall be the Mortlocks Island 14 Development Authority (MIDA); the allottee of the funds appropriated under subsection 5(3) of this act shall be the 15 16 Mayor of Weno Municipal Government or his designee; the allottee 17 of the funds appropriated under subsection 5(4) of this act shall be the Southern Namoneas Development Authority; the 18 allottee of the funds appropriated under subsection 5(5) of this 19 20 act shall be the Faichuk Development Authority. The authority of the allottee to obligate funds appropriated by this act shall 21 22 lapse on September 30, 2022. 23
