A BILL FOR AN ACT

To further amend Public Law No. 17-36, as amended by Public Laws Nos. 17-48, 17-78, 17-87, 18-36, 18-60, 18-65, 18-84, 19-22, 19-109, 20-17, 21-18 and 21-124, by amending section 6 thereof, to change the allotteee of certain funds previously appropriated therein, to fund public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 6 of Public Law No. 17-36, as amended
by Public Laws Nos. 17-48, 17-78, 17-87, 18-36, 18-65, 18-84,
19-22, 19-109, 20-17, 21-18 and 21-124, is hereby further
amended to read as follows:

"Section 6. Allotment and management of funds and 5 lapse date. All funds appropriated by this act shall 6 7 be allotted, managed, administered and accounted for in accordance with applicable laws, including, but not 8 9 limited to, the Financial Management Act of 1979. The 10 allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used 11 12 solely for the purpose specified in this act, and that 13 no obligations are incurred in excess of the sum 14 appropriated. The allottee of the funds appropriated under Section 2 of this act shall be the Governor of 15 Yap State. The allottee of funds appropriated under 16 17 [sections 3 and 4] section 3 of this act shall be the Mayor of Lelu Town Government or his designee. The 18 19 allottee of funds appropriated in section 4 of this act

1 shall be the President of the Federated States of 2 Micronesia or his designee; EXCEPT THAT, the allottee 3 of funds appropriated under subsection 4(1)(b), 4(3)(a)and (b) of section 4 of this act shall be the Pohnpei 4 Transportation Authority. The allottee of funds 5 6 appropriated under subsection 4(2)(j) of section 4 7 shall be the Chief Magistrate of Sokehs Municipal Government. The allottee of funds appropriated under 8 subsections 5(1) and 5(6) of section 5 of this act 9 10 shall be the Governor of Chuuk State or his designee. The allottee of funds appropriated under subsection 11 5(2) of section 5 of this act shall be the Mortlock 12 13 Islands Development Authority; the allottee of funds 14 appropriated under subsection 5(3) of section 5 of this act shall be the Mayor of Weno Municipal Government or 15 16 his designee; the allottee of funds appropriated under 17 subsection 5(4) of section 5 of this act shall be the Southern Namoneas Development Authority. The allottee 18 of funds appropriated under subsection 5(5) of section 19 20 5 of this act shall be the Faichuk Development 21 Authority. The allottee of funds appropriated under 22 subsection 5(6)(f) shall be the President of COM-FSM. 23 The authority of the allottee to obligate funds 24 appropriated by this act shall lapse on September 30, 2022." 25
