A BILL FOR AN ACT

To appropriate the sum of \$7,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2021, for the purpose of funding priority infrastructure projects and other public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$7,000,000, or so much thereof as may
- 2 be necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending
- 4 September 30, 2021, for the purpose of funding priority
- 5 infrastructure projects and other public projects and social
- 6 programs for the people of Yap, Kosrae, Pohnpei and Chuuk states.
- 7 The funds appropriated under this section shall be apportioned as
- 8 follows:

- 10 subsection 5(2) of this act shall be the Mortlocks Island
- 11 Development Authority (MIDA); the allottee of the funds
- 12 appropriated under subsection 5(4) of this act shall be the
- 13 Southern Namoneas Development Authority; the allottee of the funds
- 14 appropriated under subsection 5(5) of this act shall be the
- 15 Faichuk Development Authority. The authority of the allottee to
- 16 obligate funds appropriated by this act shall lapse on September
- 17 30, 2023.
- 18 Section 7. This act shall become law upon approval by the
- 19 President of the Federated States of Micronesia or upon its
- 20 becoming law without such approval.
