A BILL FOR AN ACT

To further amend Public Law No. 21-180, as amended by Public Law No. 21-191, by amending section 6 thereof, to change the allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 21-180, as amended by
- 2 Public Law No. 21-191, is hereby further amended to read as
- 3 follows:

4 "Section 6. Allotment and management of funds and lapse 5 date. All funds appropriated by this act shall be allotted, managed, administered and accounted for in 6 7 accordance with applicable laws, including, but not 8 limited to, the Financial Management Act of 1979. The allottee shall be responsible for ensuring that these 9 10 funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that 11 12 no obligations are incurred in excess of the sum 13 The allottee of the funds appropriated under section 2 of this act shall be the Governor of Yap 14 15 State or his designee. The allottee of funds 16 appropriated under sections 3 and 4 of this act shall be the President of the Federated States of Micronesia or 17 18 his designee; PROVIDED THAT; the allottee of funds

appropriated under subsection 4(1)(b) of this act shall be the Secretary of the Department of Health and Social Affairs or his designee; the allottee of funds appropriated under subsections 4(1)(c) and 4(1)(d) of this act shall be the Secretary of the Department of Justice or his designee; the allottee of funds appropriated under subsection 4(1)(e) of this act shall be the Secretary of the Department of Resources and Development or his designee; the allottee of funds appropriated under subsection 4(1)(f) of this act shall be the Secretary of the Department of [Finance and Administration | Transportation, Communications and Infrastructure or his designee; the allottee of funds appropriated under section 3(1) of this act shall be the Governor of Kosrae State or his designee; the allottee of funds appropriated under subsection 3(2) of this act shall be the Mayor of Lelu Town or his designee; the allottee of funds appropriated under subsections 4(1)(a), 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(d), 4(2)(e), 4(2)(f), 4(2)(g) and 4(2)(h) of this act shall be the Secretary of the Department of Transportation, Communications and Infrastructure; the allottee of funds appropriated under subsection 4(2)(i) of this act shall be the Chief Magistrate of Sokehs Municipal Government; the allottee of funds appropriated under subsections

1 4(3)(a) of this act shall be the Pohnpei Transportation 2 Authority (PTA); the allottee of funds appropriated under subsection 4(3)(e) of this act shall be the Vice 3 President of the Federated States of Micronesia or his 4 5 designee; the allottee of funds appropriated under 6 subsections 4(3)(b), 4(3)(c), and 4(3)(d) of this act 7 shall be the Meninkeder of Madolenihmw. The allottee of the funds appropriated under subsections 5(1) and 5(6) 8 of this act shall be the Governor of Chuuk State or his 9 10 designee; the allottee of the funds appropriated under subsection 5(2) of this act shall be the Mortlocks 11 12 Island Development Authority (MIDA), the allottee of funds appropriated under section 5(3) of this act shall 13 14 be the Mayor of Weno Municipal Government or his designee; the allottee of the funds appropriated under 15 subsection 5(4) of this act shall be the Southern 16 17 Namoneas Development Authority; the allottee of the funds appropriated under subsection 5(5) of this act 18 shall be the Faichuk Development Authority. The 19 authority of the allottee to obligate funds appropriated 20 21 by this act shall lapse on September 30, 2022." 22
