## A BILL FOR AN ACT

To amend Public Law No. 21-43, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 4 of Public Law No. 21-43 is hereby

The 4 allottee of funds appropriated under sections 3 and 4 of 5 this act shall be the President of the Federated States of Micronesia or his designee; PROVIDED THAT, the 6 7 allottee of funds appropriated under subsection 3(1) of this act shall be the Governor of Kosrae State or his 8 9 designee; the allottee of funds appropriated under 10 subsection 3(2) of this act shall be the Mayor of Lelu 11 Town Government or his designee. The allottee of funds appropriated under section 4(1) and 4(3)(1) of this act 12 13 shall be the Vice President; PROVIDED THAT, the allottee 14 of funds appropriated under subsection 4(1)(a) of this 15 act shall be the Mayor of Mwoakilloa Municipal 16 Government or his designee. The allottee of funds 17 appropriated under section 4(2) of this act shall be the 18 Secretary of the Department of Transportation, 19 Communications and Infrastructure or his designee, 20 except that the allottee of funds appropriated under 21 subsections 4(2)(e), 4(2)(j), 4(2)(m), 4(4)(j), 4(4)(k), 22 4(4)(1) and 4(4)(m) of this act shall be the Pohnpei Transportation Authority (PTA); the allottee of funds 23 appropriated under subsections 4(2)(1), 4(3)(d) and 24 25 4(3)(f) of this act shall be the Secretary of the

Department of Education or his designee; the allottee of 1 2 funds appropriated under subsection 4(2)(h) of this act 3 shall be the President of COM-FSM; the allottee of funds 4 appropriated under subsections 4(3)(a), 4(3)(b), 5 4(3)(e), 4(3)(h), 4(3)(i) and 4(3)(k) of this act shall be the Meninkeder of Madolenihmw; the allottee of funds 6 7 appropriated under subsection 4(3)(c) of this act shall be the Chief Justice of Madolenihmw Municipal 8 9 Government; the allottee of funds appropriated under 10 subsection 4(3)(g) of this act shall be the 11 Luhkenmoanlap of Kitti; the allottee of funds appropriated under subsection 4(3)(j) of this act shall 12 13 be the Speaker of Isokonedi of Kitti. The allottee of 14 the funds appropriated under sections 5(1), 5(3) and 15 5(6) of this act shall be the Governor of Chuuk State or 16 his designee; the allottee of the funds appropriated under subsection 5(2) of this act shall be the Mortlocks 17 18 Island Development Authority (MIDA); the allottee of the 19 funds appropriated under subsection 5(4) of this act 20 shall be the Southern Namoneas Development Authority; 21 the allottee of the funds appropriated under subsection 22 5(5) of this act shall be the Faichuk Development Authority. The authority of the allottee to obligate 23 24 funds appropriated by this act shall lapse on September 30, 2022." 25
